Minutes of the Ordinary Parish Council Meeting of the Stanton-by-Dale Parish Council held at 7.30pm, on Thursday 1st September 2016, in the Village Hall, Stanhope Street, Stanton-by-Dale.

250/2016 Election of Vice Chairman.

Ralph Homer was unanimously elected as Vice Chair

251/2016 Vice Chairman to sign Declaration of Office.

Cllr Homer and the Clerk signed the Declaration of Office.

253/2016 Variance in Order of Business – Item 14 to be moved to the end of the meeting with public excluded.

254/2016 Declaration of Members Interests – None.

255/2016 Public Speaking – (15 minutes) –

A parishioner who walks down Quarry Hill has complained that the hedge is overgrown. Cllr Frudd (EBC) says it is in hand and expected to be done September.

Chair had been approached re the parked cars on Flake Lane and it has been put onto the agenda.

Councillor asked for the development of the allotments to be put onto the next agenda.

Long Eaton Cycling Club have been on Quarry Hill doing time trials up and down the road and it was thought to be dangerous and to be put onto the next agenda.

Transco are parking trailers on Quarry Hill and it is hard to get round them. Cllr Coates will talk to them about this and will come back to us if necessary.

Reports from Outside Bodies.

Police - PCSO Karen Pykett sent her apologies due to holidays. Crime figures up to 19th August were as follows. On 4th August on Sowbrook Lane, there was a drugs problem with a vehicle stopped, searched and seized and on 18th August on Littlewell Lane there was the theft of a trailer.

EBC – It was noted that the previous planning application for Stanton was withdrawn at the planning meeting. Steve Birkinshaw has now done a traffic modelling exercise. Some ideas have been put forward but nothing is final. Suggestions are an island at Moorbridge Lane and Kirk Hallam relief road from Sowbridge Road behind twelve houses to Ladywood Road. This won't be done as part of the SPD and will need to be another planning. HS2 will have an impact.

Bulls Head island may be traffic signal controlled as part of other development.

DCC – Has been very quite at the moment with no cabinet meeting for 5 weeks. The Safer Neighbourhood Team covering Erewash have a new sergeant in charge, Damien Shannon. Stanton information will discussed in item 12.

Previously objected and this still stands for the amended application.

Clerk was also asked to write to DCC Highways regarding the four applications in the same area and at what stage would a consultation regarding the additional traffic become necessary.

260/2016 Broadband/Updated website – Reply received from DCC.

Clerk read out the email received from ClIr Dean Collins, Cabinet Member for Highways, Transport & Infrastructure which was not very encouraging with regards to the fast speed broadband in the village. Dave Owens has contacted BT Openreach twice recently with no response but he will keep chasing them.

261/2016 Stanton Regeneration.

Thirty two people attended a public meeting and 14 responses were fed back to Steve Birkinshaw a couple of days ago. It was thought that it was a good meeting but from what has been said tonight it has changed. No new roads are viable and will not work and there isn't enough finance (total £8 million) to implement main changes. Supplementary Planning Document will now go out to consultation in the near future; it is on the EBC Web site. It is looking as though it will be traffic calming etc in the village. EBC want what is best for the site and have encouraged residents to take part. There is a 'Drop In' arranged by EBC in the Village Hall from 2.00pm to 6.00pm on Wednesday 21st September.

262/2016 8 Stanhope Street.

The work has now been completed and the invoice received.

263/2016 Village Triangle.

It was agreed to put this item on the next agenda, meanwhile Clerk to check how near the road edge the planter can be before the PC decide whether to complete the 'Object Licence' application.

The white lines have re-appeared (these weren't previously burnt off) at the Main Street, Stanhope Street junction, Clerk to contact DCC urgently due to traffic health and safety

264/2016 Village Hall.

a) Refurbishment – no quotes yet. Keep on the agenda.

265/2016 Neighbourhood Planning.

Cllr Martin to be contacted with dates.

266/2016 Memorial to Dale Road Air Crash.

Cllr Homer has been to see his contact at Martin Bailey's and spoke to his son Daniel and had information of a memorial which would be 7ft high, 3 ft wide, granite look-alike (any shape required). Cost for that would be £5795.00 for hand cut lettering and this price includes installation.

Cllr Harvey also had some information to hand out which he asked Councillors to look at before the next meeting. This item is to be moved up the agenda for next meeting.

267/2016 HGV's - Speed camera in village.

Cllr Harvey has looked at having a speed camera at the village entrance and he has been advised that it would need to be calibrated and would not be able to be enforced by the police.

Cllr Harvey expressed frustration at not getting anything done about the HGV's and handed out a copy of an email with suggestions to look at and discuss at next meeting (This item also to be moved higher up the agenda).

The two new notice boards are now up. The key for the General Notice Board is with the Chair and a notice will be put up to let residents when and how to obtain the key. It was agreed to try and find out if anyone would like the old Notice Board as it is still useable.

2702016 Parked Cars on the bottom of Flake Lane.

An anonymous email was read out asking why the Parish Council aren't doing anything about this problem. It was discussed and agreed that we are unable to do anything as this is private land.
